



Welcome

The Riverside County Mock Trial competition has grown dramatically since its inception in 1983. This year over 475 students from 24 high schools have entered the competition. During the last 43 years, over 15,000 students have experienced the lasting value of this program. Through the collaborative efforts of the co-sponsors, the Riverside County Office of Education, Riverside County Bar Association, and Riverside County Superior Court, this event has become a traditional celebration of student achievement.

The Riverside County Mock Trial program demonstrates a county-wide community effort that supports education and brings together parents, teachers, attorneys, judges, and community members to promote a greater appreciation and understanding for the law, court procedures, and the American judicial system. Thank you for joining us in our passion and responsibility for educating Riverside County students.

Mock Trial Overview

Mock Trial is a simulation of a criminal case, with students acting as each of the principals in the cast of courtroom characters. Mock Trial is designed to demonstrate the workings of our legal institutions for young people. The student teams study a hypothetical case, complete legal research, and are coached in courtroom procedure and trial preparation by teacher coaches and volunteer attorneys. Students participate as counsel, witnesses, and court clerks, presenting their cases in courtrooms before actual federal and state judicial officers who have volunteered their time.

Each Mock Trial team will compete in the actual court setting at least four (4) times until the final round, which will take place on Tuesday, February 18, 2025.
