

#### Projected Revenue by Fund Source




This chart shows the total general purpose revenue Nuvieu Union School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Nuvieu Union School District is \$31,122,203, of which \$21,911,185 is Local Control Funding Formula (LCFF), \$5,659,361 is other state funds, \$2,593,079 is local funds, and \$958,578 is federal funds. Of the \$21,911,185 in LCFF Funds, \$6,169,218 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The text description of the above chart is as follows: Nuvieu Union School District plans to spend \$32,951,228 for the 2024-25 school year. Of that amount, \$10,281,830 is tied to actions/services in the LCAP and \$22,669,398 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

The budgeted expenditures that are not included in the LCAP will be used for, but not limited, to the following: staffing, general supplies, insurance, utilities, maintenance, custodial, grounds, facility needs, technology needs, transportation, special education, and professional development.

## Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Nuvieu Union School District is projecting it will receive \$6,169,218 based on the enrollment of foster youth, English learner, and low-income students. Nuvieu Union School District must describe how it intends to increase or improve services for high needs students in the LCAP. Nuvieu Union School District plans to spend \$5,922,691 towards meeting this requirement, as described in the LCAP.

After reviewing data with educational partners, 30% of our student population are English Learners who are not making adequate progress. With the knowledge of this data and doing a comprehensive needs assessment at each of the school sites, it was determined that students aren't being provided Designated and Integrated ELD on a consistent basis. Teachers will have specific planning time to address the needs of English Learners. This will allow them to analyze student data, plan designated lessons and ensure ELD standards are being addressed in integrated strategies in Core subject areas. The difference in projected funds and budgeted expenditures amount of \$246,527 has an equivalent contributing percentage of

1.6895% that is being provided to increase services to high needs students.

## Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

In Action 1.1, for the 2023-2024 school year, we provided training on district-wide initiatives in Amplify Science Curriculum, Math Strategies, Autism Training, and other identified best instructional practices. In Action 1.2, we utilized supplemental materials to assist in delivering the core curriculum. 42.5% of our English Learners were progressing towards English Language proficiency as measured by the Summative ELPAC assessment and reported on the CA Dashboard. In Action 1.3, our data shows that the work of our intervention teachers and the use of PE teachers is working. We were able to provide intervention to more of our students this year, especially in the area of math. In Action 1.4, we continued to offer additional instructional minutes, providing 60 additional minutes each week for the first-best instruction. In Action 1.5, after eight years of providing a STEM program at our elementary sites, we shifted the STEM lab to more of a Makerspace. This continued to enrich our students and increase their engagement with more current materials. We continue exploring opportunities to improve students' engagement through Arts and Music. In Action 1.6, our focus on staff-to-student ratio this school year enabled us to provide students with ratios below our metric. For the 2023-2024 school year, the class size ratios are as follows: TK-3: 21, 4-6: 29, 7-8: 26. In Action 1.7, we added a speech and language pathologist to meet the increased needs of our students. We also provided PD for special education staff in the area of autism and supplemental curriculum in the area of ELA. In Action 1.8, we expanded the after-school offerings to our students by creating one comprehensive program that provided students with homework assistance, ELA and math intervention, physical exercise, and enrichment opportunities. We prioritized unduplicated student enrollment in the program to guarantee a spot for every student who wanted to participate.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 1.6 Staff-to-Student Ratios: Additional funds of \$200,000 were spent in this area as TK and Kindergarten instructional assistants were moved to these areas, contributing to reducing staff-to-student ratios. This assisted in better serving our unduplicated students by providing them with more small-group and individual learning opportunities.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

In many areas of Goal 1, we fell short of making progress. The baselines were taken from 2019 data. With the data provided as the baseline being pre-COVID, we have found that we have had a long path to get back to the original baseline data before showing progress above the baseline data.

Action 1.1 Professional Development on District-Wide Instructional Initiatives. While we met this goal for our certificated staff, we are including it in our next cycle to improve professional development for classified staff.

Action 1.2 Supplemental Instructional Programs and Materials. We have been analyzing the effectiveness of using IReady for our middle school students. By year eight of using the program, we are not seeing the academic benefit for our middle school students, so we are researching other supplemental programs that may offer more support.

Action 1.3 Our data shows that the work of our intervention TOSAS and the use of PE teachers is working. We provided intervention to more of our students this year in smaller group settings, and additional interventions were provided to our students in math and English.

Action 1.4, 1.5, 1.6, and 1.8- The district has effectively fulfilled these actions, contributing to student progress. Students have received 36 additional hours of first, best instruction through the extension of the school day. Students are provided additional ELA and math intervention and enrichment through our Extended Learning Opportunities taught by our credentialed teachers. The metrics of ensuring highly qualified staff 95%, implementation of state standards 100%, and offering a broad course of study all contribute to the effectiveness of fulfilling these actions. For the 2023-2024 school year, the class size ratios are as follows: TK-3: 21, 4-6: 29, 7-8: 26, which is lower than the prior years in the plan.

Action 1.7- The district has effectively made progress with this action. Unduplicated students with disabilities have been provided with additional staff to reduce the ratio, and additional supplemental programs and staff have been provided with Professional Development. This action has been continued in the LCAP based on not meeting the metrics set to measure this action. Students with disabilities continue to score low/very low on the California Dashboard in the areas of math, ELA, and ELD.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

All actions in Goal 1 and 2 will be implemented in the 24-25 LCAP. Metrics for several of these actions have been changed to ensure that we are gathering the most accurate data to determine that we are meeting the goals and actions described. Goal 3 and the actions included in that goal will be incorporated into Goal 1 as technology is viewed as a resource to allow unduplicated students to access the curriculum better.

Goal 1 has been changed to reflect technology as a resource within the goal.

Action 1.1 Based on the current needs of the students and desired outcomes, we have changed the professional development focus for staff to focus on math and English Language Development, which are two areas of need shown on the 2023 Dashboard.

Action 1.2- Based on the current needs of the students and desired outcomes, supplemental programs formerly used will no longer be used, and new supplemental programs will begin. A description of any substantive differences in planned actions and actual implementation of these actions.

Nuvieu Union School District implemented most of Goal 2 actions. We continued to see an increased need for social-emotional support for our students.

Action 2.1 Staff received professional development in the Second Step Curriculum and a district social worker was hired.

Action 2.2 Sites used their site allocations to ensure they intentionally supported unduplicated students. Sites focused on student attendance to ensure first, best instruction. Chronic Absenteeism (All Students), Dashboard Rate (2023): 31.9% Dashboard Status (2023): Very High. While this rate was still high, it was a 13.8% decrease from the previous year.

Action 2.3 The district provided additional counseling services to our unduplicated students.

Action 2.4 For the 2023-2024 school year, 847 students (56.03%) used the free home-to-school transportation offered. NES- 46.94%VVES- 50.86%MSMS- 81.60%.

Action 2.5 The increased health services provided to students helped to support increased attendance. For the 2023-2024 school year, the district-wide average daily attendance rate is 93.65%, an increase of 2.43% from the previous year.

Actions 2.6, 2.7, and 2.8 were implemented as planned.

Action 2.6 In this action, we saw a decrease from the baseline in the metric of parents feeling welcome on campus. As a district, we are continuing to explore ways to increase the number of parents who feel welcome on campus by sharing with site staff the open-ended results of the survey, where parents have provided us with specific information.

Action 2.7 In this action, we saw a decrease from the baseline. This prompted a follow-up survey of our 5th- 8th grade students. As a result, we have added a security guard to the elementary site that did not previously have one. This is to increase students' feelings of safety on the school site. The increased feeling of safety will allow students to focus on their learning.

Action 2.8 In December 2023, all of our sites scored an overall " good " ranking on the annual FIT inspection.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 2.7 there was an increase in the budget of \$160,161 in the area of communication, safety and security due to additional monies being spent through the safety committee on fencing, buzzer access to campuses and campus security. This showed as a high priority to educational partners in the LCAP survey.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

2.1 Professional development in the area of Second Step was provided to all middle school staff. Metrics of suspension data from the 2023 Dashboard are not showing the results anticipated. Second Step will be part of a new elective wheel for students to ensure all students are receiving consistent SEL curriculum. In addition, we hired a social worker who runs a wellness center at the middle school. Based on the

reduction in the number of suspensions this school year at the middle school, we are anticipating 2024 Dashboard improvement in the area of suspension at the middle school.

2.2, 2.3, 2.4, 2.5, and 2.8 Have been effective in making progress towards the goal. While not every metric was met, steady progress was made in the outcomes over the three-year cycle.

2.6 and 2.7 These actions will be continued in the new LCAP cycle, as the progress desired wasn't achieved based on the metrics set and is considered ineffective. New metrics have been established, additional staff will be hired, and systems will be put in place to achieve the desired outcome over the next LCAP cycle. 2.1 This action has been changed to provide staff training in trauma-informed practices and to expand Pro-Act Training.

2.2 Principals have attended professional development in Strategic Planning. Site SPSAs will be more aligned to the LCAP and site allocations utilized to address the actions developed to address site-specific needs.

2.4 Metric changed to reflect student attendance when transportation is provided.

2.7 The budget for this action has been significantly changed to address the safety needs at all three of our school sites by adding additional staff and safety measures.

2.8 The budget for this action has changed significantly due to the completion of providing new furniture to the sites.

The technology department was able to address 1,537 technology tickets during the 23-24 school year. 12 families accessed a MiFi to have internet access and 55 laptops were purchased to maintain the 1:1 device ratio.

For the 2023-2024 school year, over 95% of our students are accessing these available online tools, programs, and applications. While effective, the three actions in this goal will be incorporated into Goal 1 as technology is a resource that allows students to access the curriculum.

This goal has been eliminated and incorporated into the new goal of increasing academic proficiency in literacy, numeracy, and 21st-century competencies through the implementation of high-caliber teaching methods and learning strategies. Actions 3.1, 3.2, and 3.3 will all be incorporated into Goal 1. This will incorporate technology into student's academic progress. The metrics developed will be regarding student performance.

## Plan Summary [2024-25]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Nuvview Union School District (NUSD) is a small district serving students from transitional kindergarten to 8th grade in the Lakeview, Perris, and Nuevo communities. It is comprised of two elementary schools for TK-6th grade and one middle school for 7th and 8th grades, with a total student population of approximately 1500 students. The current Average Daily Attendance stands at 93.0%. 83% of NUSD students are classified as Socio-Economically Disadvantaged, and 31% are English language learners (EL). The student body is predominantly Hispanic (84%), followed by White (10%) students, with smaller percentages of African American (.8%), multiracial (2.2%), Asian (0.4%), American Indian (0.1%), Filipino (0.1%), and Pacific Islander (0.1%) students. Additionally, 13.6% are students with disabilities (SWD), 8.5% are experiencing homelessness, and 0.4% are foster youth.

NUSD is committed to fostering high expectations, beginning with quality classroom instruction. The curriculum includes Eureka Math for all grades, Engage New York ELA for grades 4 through 8, and McGraw Hill Wonders for TK-3. Amplify Science is used TK-8 to address Next Generation Science Standards and TCI for Social Studies. Two Teachers on Special Assignment (TOSA) per elementary school provide Tier 2 Intervention in math and English language arts, while the middle school TOSA focuses on English language arts. Intervention programs such as I-Ready are utilized, with Read 180 at the middle school level. Additionally, elementary schools have full-time PE teachers to support small group interventions. Positive Behavior Intervention Supports (PBIS) are implemented district-wide.

Safety is a top priority, emphasized through feedback from educational partners and addressed by board subcommittees like the Safety Subcommittee and Facilities Subcommittee, ensuring community engagement and prioritizing safety in decision-making.

Our local data (iReady) shows that 70% of our students are performing at least one grade level below in reading, and 80% are performing at least one grade below in math. According to our local data, 79% of our English Learners are one or more grade levels below in reading, and 88% of our English Learners are one or more grade levels below in math.

The LEA will address these concerns through focused professional development in math and ELD. Increased staffing for students with disabilities to lower ratios and a focus on chronic absenteeism at school sites with incentives for improved attendance. In addition, continued focus on ELs through teacher planning time and intervention for the unduplicated students.

Areas that have shown growth on the 2023 California School Dashboard include the Chronic Absenteeism rate, which declined by 13.9%. Schools focusing on chronic absenteeism through the SART/SARB process, educating families on attendance, and awarding students for improved attendance are attributed to this success.

## Reflections: Technical Assistance

The 2023 California School Dashboard shows that our Students with Disabilities are eligible for Differentiated Assistance in ELA, Math, and Suspension. In addition, our English Learners are eligible in math and suspension.

District leaders and site principals have participated in Differentiated Assistance meetings and the Compliance and Improvement Monitoring Process to establish the root causes of these students' challenges. Through this process, we have established plans to address the concerns.

In the CIM plan, there was one activity that was created to address the root causes:

1. Using short-term independent study at a greater rate than just missed school days.

In the DA meetings, the district is moving forward with the following plans:

Training in the area of mathematics for all teachers TK-8th grade.

Teachers are trained in designated and integrated ELD. This training incorporates both GLAD training and designated ELD lesson studies. In addition, supplemental materials are accessed to better support newcomer students in the district.

To address suspension, we have curriculum to address ATS. We will work to educate parents by hosting parent information nights. We are working on adding sensors and other devices to address the current vaping problem.

Gathering feedback from our educational partners helped the district to see trends in areas that need to be addressed within the LCAP. During staff LCAP meetings and LCAP PAC meetings, it was determined that our technology goal from the 2021-2024 LCAP could be incorporated into the ELA and Math goal as the technology is a tool to support learning.

During LCAP PAC meetings and the onsite staff LCAP meetings, a need was brought forth about the performance of our English Learners and additional support is needed for these students. Based on this, the district developed a new goal to directly address the needs of our students identified as English Language Learners. Additional training for staff, supplemental materials, and systems to ensure quality instruction and monitoring of our English Language Learners. (Goal 2- Action 1, 2, and 3)

In the LCAP survey, LCAP PAC meetings, and Staff LCAP meetings, a trend about student safety and connectedness emerged. Based on this, the district added action 3.6, Safety and School Connectedness, to ensure each site has a school security guard on campus throughout the school day.

Certificated staff are contracted 7.5 hours day.  $10/450 = .22$  improved service time for English Learners. Based on the projected certificated salary and benefits of \$11,093,708.00, this is equivalent of \$246,527.00.

The planned percentage of improved services is calculated as  $\$246,527/\$14,591,862.00$  (LCFF base) = 1.6895% of improvement.

### ***Additional Concentration Grant Funding***

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Additional concentration grant add-on funding supplements actions 1.6, 1.8, 3.6, and 3.7. In action 1.6, we continued using the concentration grant add-on to retain three additional teacher positions hired to lower class size ratios beyond the bargaining unit contract class sizes. In action 1.8, we continued the two assistant principal positions and used the concentration grant add-on funding for approximately 50%

of the salaries. The intent of these positions is to monitor our unduplicated students with individual learning plans and provide assistance in programs and interventions. These positions plan and administer our after-school and extended learning programs for unduplicated students. In action 3.7, we continued the additional custodial positions to provide direct service to students by ensuring our campuses remain clean and safe. In action 3.6, we added the position of campus security at each school for the direct safety and security of our students.

  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
  - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
