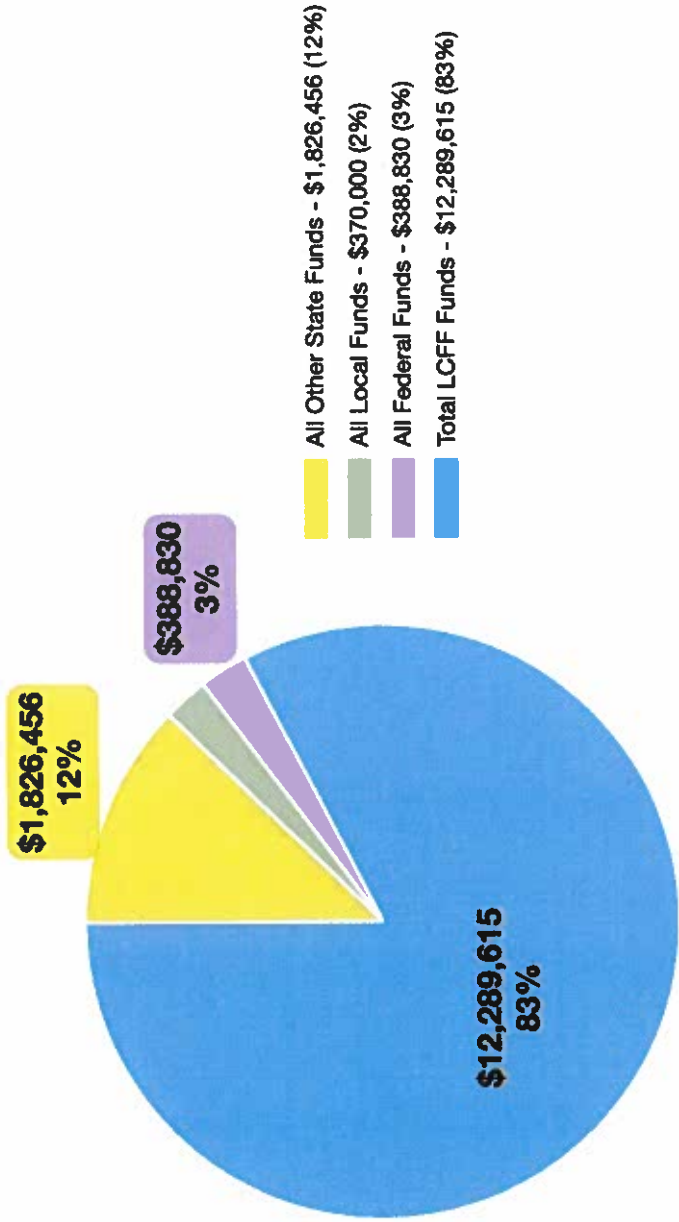

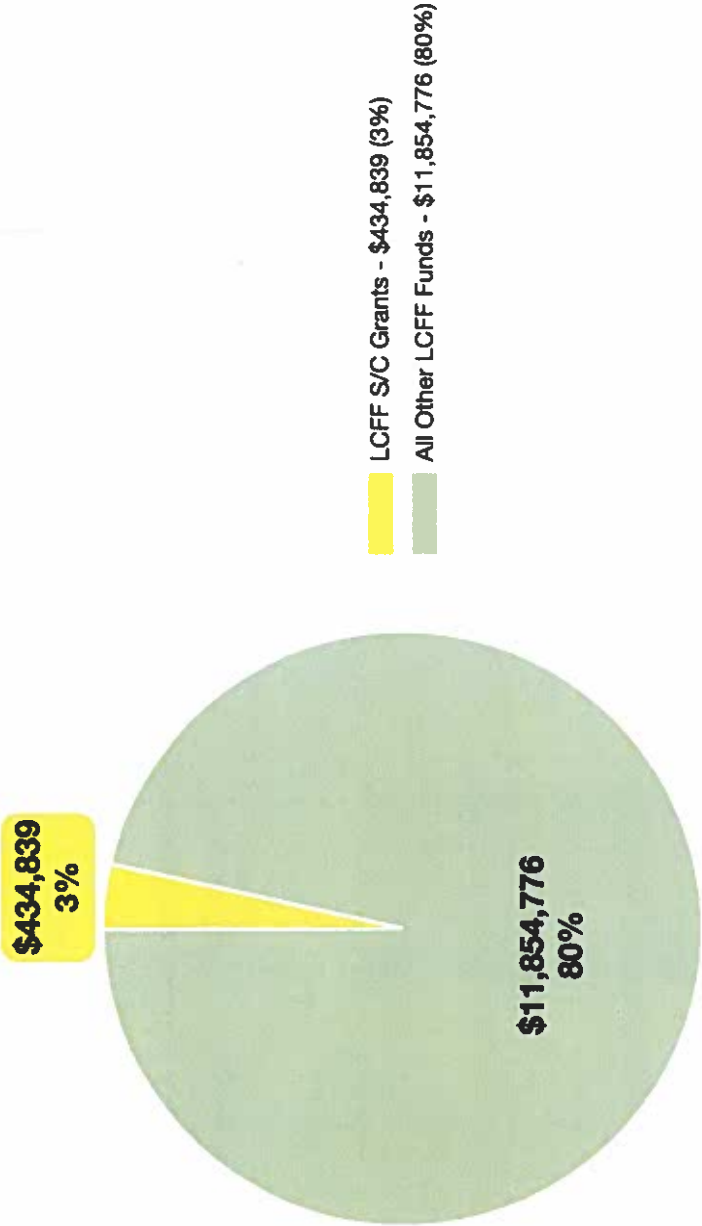

Breakdown of Total LCFF Funds



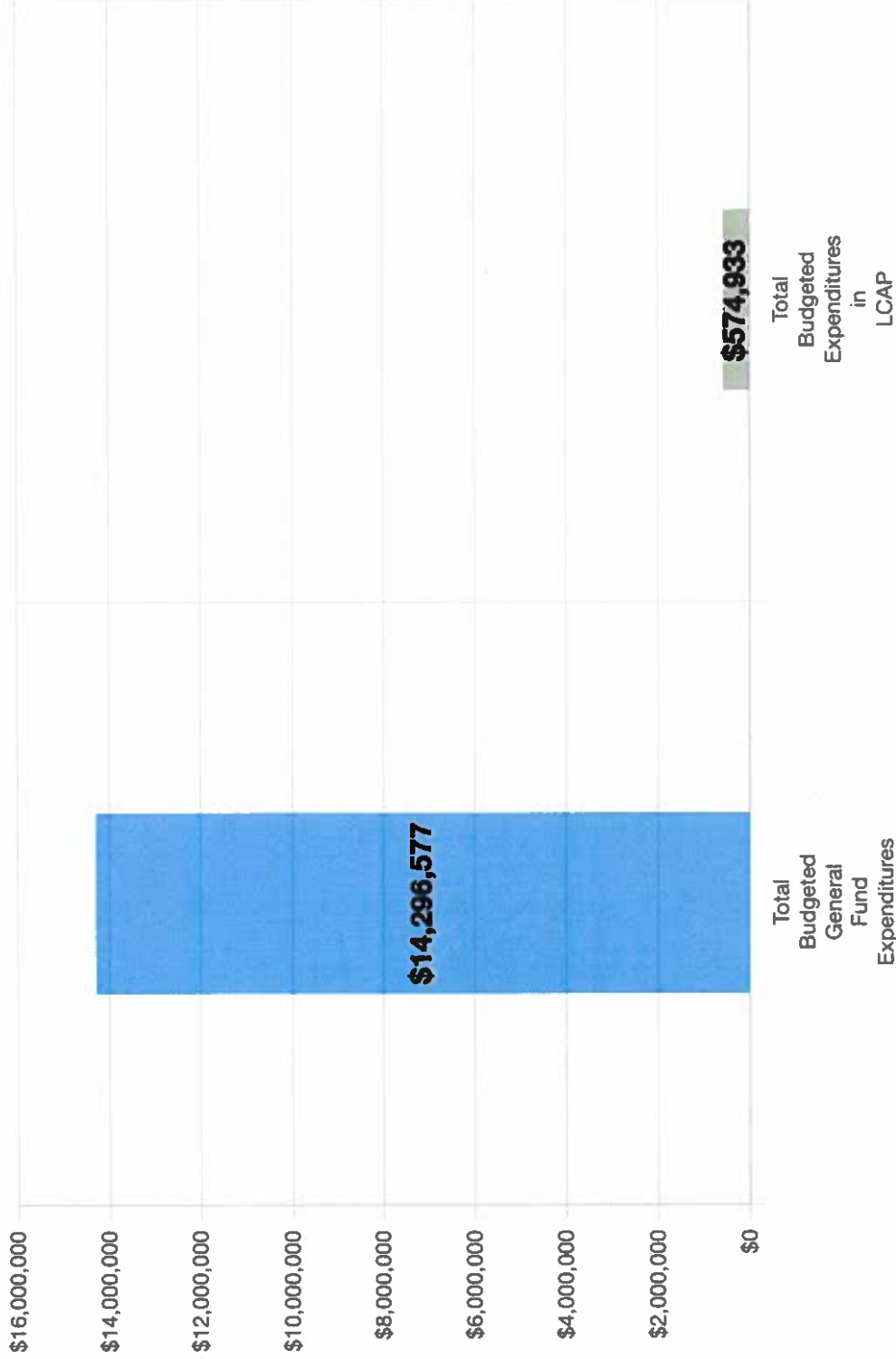

These charts show the total general purpose revenue Temecula Preparatory expects to receive in the coming year from all sources.

The total revenue projected for Temecula Preparatory is \$14,874,901, of which \$12,289,615 is Local Control Funding Formula (LCFF), \$1,826,456 is other state funds, \$370,000 is local funds, and \$388,830 is federal funds. Of the \$12,289,615 in LCFF Funds, \$434,839 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use funds to serve students.

Budgeted Expenditures in the LCAP



This chart provides a quick summary of how much Temecula Preparatory plans to spend for 2025-26. It shows how much of the total is tied to planned actions and services in the LCAP.

Temecula Preparatory plans to spend \$14,296,577 for the 2025-26 school year. Of that amount, \$574,933 is tied to actions/services in the LCAP and \$13,721,644 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

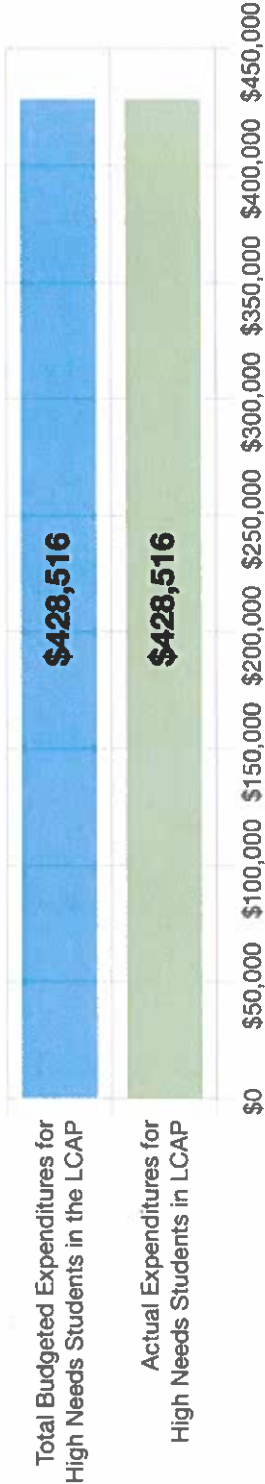
- 1) teachers (salaries/benefits) for the general instruction of students using our classical education curriculum, 2) administrators, business, and facilities personnel for keeping our school operational, and 3) expenditures related to general overhead, utilities, maintenance and other operational costs of the school.

Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Temecula Preparatory is projecting it will receive \$434,839 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary 2025-26

General Information

Temecula Preparatory School (TPS) is a public, charter school that serves approximately 1,100 students in grades TK-12 of the Temecula Valley Unified School District (TVUSD) and surrounding area. TPS began serving students during the 2000-01 school year. TPS seeks to enroll a diverse student population reflective of the district and community it serves.

Temecula Preparatory School’s mission is to inspire students to become virtuous citizens, critical thinkers, and life-long learners through a classical education. The classical education curriculum focuses on the trivium, a teaching model that seeks to tailor the curriculum subject matter to each student’s stage of cognitive development. The trivium emphasizes concrete thinking and memorization of facts in grades TK-4, analytical thinking and understanding of the subject matter in grades 5-8; and abstract thinking and articulation of the subject matter in high school. TPS has maintained a strong classical program while incorporating the Common Core State Standards. The classical curriculum, through high expectations, is an approach which is designed to encourage all students to rise to their maximum performance.

Central to all learning at TPS is the need to instill a "passion" for knowledge, a curiosity to know the unknown, to explore new areas, to expand the mind and open new doors to ideas built upon wisdom and knowledge acquired in and from the past. TPS believes this can be accomplished through a well- structured, safe, and caring environment. The teaching staff work to instill a passion for learning and inquisitiveness toward things beyond present knowledge. Support and consistency are enforced by all stakeholders, including caring teachers and staff, as well as parents.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The latest results from the California School Dashboard demonstrate that Temecula Prep students perform significantly better than the state averages on every measure included in the Dashboard. The school is particularly pleased to see our students perform 49.9 pts higher than the statewide average in ELA and 41.2 pts higher than the statewide average in mathematics.

From a year-over-year comparison, the biggest statistical difference of any metric on the Dashboard was in math, where Temecula Prep students scored 4.5 pts higher than the previous year. This is particularly encouraging because improving students' performance in math is one of our LCAP goals. Of our student subgroups, students of Two or More Races achieved the biggest performance increase, with scores rising 32.9 pts from the previous year.

The results as measured by other Dashboard metrics were similar to those of the previous year, with a slight decrease in performance in chronic absenteeism and student suspension rate and slight increase in performance on the college and career readiness metric.

Our local data has been encouraging as well. Although students enrolling into Temecula Prep for the first time are arriving with weaker math and ELA skills than they did historically, our improved RTI program and RTI strategies are proving effective in identifying student needs and improving student outcomes. For example, using a robust support program, we are currently achieving higher course passage rates of high school students in the traditionally high failure rate classes of Algebra and Geometry.

Temecula Preparatory School uses a variety of strategies to engage with our educational partners as described above. Because the school enjoys a strong level of participation from its parents and actively involves parent volunteers in the classroom, we are also able to communicate and get feedback from parents on a daily basis in addition to the more formal ways listed in the table above. Based on feedback from our educational partners (and from supporting data analysis), Temecula Preparatory School has prioritized improvement in student mathematics in our LCAP. In particular, the school has brought back the leveling of math classes in the lower school, a practice that was discontinued during the school's transition to a new math curriculum. While allowing advanced students to move to a higher grade level during math instruction requires extra coordination, we can see the benefit and are pleased with the results after re-instituting this practice at our school.

Goal Analysis

A description of any substantive differences in planned actions and actual implementation of these actions.

All of the actions planned to help achieve Goal #1 are currently in the process of being implemented and progress is being made with each. Among these actions, the school is particularly excited about the progress being made with Actions #3 and #4. Action #3, which is to improve and increase use of strategies to challenge high performing students, has been a point of emphasis this year. One of the many ways that the school is challenging high performing students is by reinstating math leveling in the lower school, which allows students who are advanced in math to move to higher grade level classrooms during math instructional time. In addition, the school has made substantial progress on Action #4, which is to provide students with social and emotional learning to promote positive mental health. In order to increase the effectiveness of the school's SEL instruction, the school has taken a more data driven approach and aligned our SEL curriculum with ASCA standards. By implementing these changes and by sharing this more robust approach with our faculty and staff so that everyone understands the strategies and goals of our SEL program, we have been able to significantly improve the program's effectiveness.

There are no material differences between budgeted expenditures and estimated actual expenditures.

We are particularly pleased with the effectiveness of the work being done with regard to Action #4 as previously described. Taking a data-driven approach to SEL instruction allows us to have a much better understanding of both student needs and program effectiveness. In a relatively short period of time, we are already seeing the positive results of this change and will continue implementing this data-driven approach as we move forward with further developing our SEL curriculum.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

We have not made any changes to the planned goal, metrics, target outcomes, or actions related to Goal #1 for the coming year because we believe the plan as formulated is still highly needed for our students' well-being and well formulated to achieve our goals.

A description of any substantive differences in planned actions and actual implementation of these actions.

All of the actions planned to help achieve Goal #2 are currently in the process of being implemented and progress is being made with each. As part of our efforts for Action #1, the school tests students multiple times during the year using Edmentum assessments and also tests any students enrolling for the first time at Temecula Prep in order to better understand their level of math proficiency. The analysis of student performance results as described in Action #2 is conducted in grade level meetings in Lower School and math department meetings in Upper School. Action #3 calls for the tutoring and extra support of low performing students and this is being done on a daily basis. There have not been any substantive changes in the planned actions and the actual implementation of these actions. Because we have experience using our new math curriculum (Eureka Math) and the same math assessment program (Edmentum) for several years now, classroom teachers and RTI staff have become increasingly adept at using the data to adjust instruction and provide targeted interventions for students who need additional support. That being said, we believe that there is still more progress we can make on this front and that there is an opportunity to make our data analysis efforts even more effective.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There are no material differences between budgeted expenditures and estimated actual expenditures.

Each of the actions for improving our math outcomes are dependent on the other actions and all work toward the same goal. Because the school's overall math scores have increased, it appears that the actions being implemented are helping us to successfully achieve our math improvement goals. Specifically, identifying student skill gaps and providing targeted instruction are fundamental strategies that appear to be working.

We have not made any changes to the planned goal, metrics, target outcomes, or actions related to Goal #2 for the coming year because our student outcomes in math are improving and our strategies as currently formulated appear to be working.
