

#### Projected Revenue by Fund Source




This chart shows the total general purpose revenue Temecula Valley Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Temecula Valley Charter School is \$9,117,892, of which \$7704306 is Local Control Funding Formula (LCFF), \$1130999 is other state funds, \$30020 is local funds, and \$252567 is federal funds. Of the \$7704306 in LCFF Funds, \$412867 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


## Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year


## Update on Increased or Improved Services for High Needs Students in 2024-25

## Plan Summary [2025-26]

### General Information

Located in the beautiful French Valley area of Temecula, Temecula Valley Charter School is celebrating its 32nd anniversary as a charter school. Founded in 1994, originally as a district charter known as Temecula Learning Center, TVCS is a thriving school focused with a family-centered approach to academic rigor, experiential learning and intense focus on science and the arts. It defines its mission as the following: Temecula Valley Charter School empowers students to become confident, capable leaders and compassionate, innovative citizens through a culture of academic excellence, creativity, and character. We cultivate a supportive, student-centered environment where learners discover their passions, develop critical thinking skills, and grow as lifelong learners. Through rigorous, standards-based instruction and enriching opportunities in the arts, sciences, athletics, and music, we prepare students to lead, serve, and thrive in high school, college, career, and an ever-changing world. Despite its small size, TVCS boasts an award winning performing arts department, a robust interscholastic sports program with at least 9 sports played annually, a recognized visual arts program highlighted during its annual community wide Art Show and various specialty clubs and activities. TVCS students also annually give back to their community through events such as "TVCS Has Heart" and our annual food drive entitled the "SouPer Bowl". Due to its centralized location in Winchester, it draws students from several surrounding cities including Hemet, San Jacinto, Romoland, Temecula, Murrieta, Menifee and Lake Elsinore. During the 2024-2025 school year, TVCS' enrollment averaged 590 students in grades TK-8th grade. The demographics of TVCS indicate that 51.9% of our students are male, 48.1% of our students are female. Data from the 2024-2025 school year indicate that our students identify as approximately 40% Hispanic, 5% Black or African American, 34% White, 10% Two or more races, 6% Asian and 4% Filipino. Unduplicated students are represented by Students with Disabilities (10%), Socioeconomically Disadvantaged (25%), Homeless (0.1%) and currently no Foster students. English Language Learners represent 2.25% of the student population.

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

A review of Dashboard Data indicates that while CAASPP assessments indicate that TVCS is performing better than the local districts and counties, a portion of our students are not meeting state standards in the area of Mathematics. Preliminary data from our most recent CAASPP administration indicate a 10 pt improvement in the number of students meeting or exceeding standards in Math. Additionally, although our students perform well in English Language Arts, the professional development and school focus has been on analyzing data to create evidence-based instruction and intervention to our students. Overall, ELA CAASPP data indicate an increase of 5% of students meeting or achieving "standard met" or "standard exceeded" on state assessments. This indicates good progress toward our Year 3 outcome goals. Our data indicates that we are continuing to make good progress in the academic achievement of subgroups such as students with disabilities, African-American students and students identifying as "more than two races". Chronic absenteeism initially identified as a challenge in the current LCAP has significantly improved with a school-wide focus on positive reinforcement of school engagement by families and students. Finally, while our dashboard data reflects low suspension and non-existent expulsion rates, AERIES guidance logs indicate on-going challenges with students being respectful to each other and to staff. The current school-wide social-emotional interventions focus on providing character development and targets intervention for those experiencing anxiety and interpersonal challenges.

Parents also participated in "reels" allowing them to provide written, auditory or video feedback on campus culture and climate. The data is then analyzed by AI to identify themes and action items.
Classroom Teachers	LCAP Engagement Meetings. During the 2024-2025 school year, teachers participated in cross-grade level and cross-departmental activities to identify the mission, vision and instructional focus for TVCS. Out of these activities a new mission and vision statement was developed.
School Staff and Administration	LCAP Survey and Data Analysis of LCAP Survey Results. School staff meetings targeted at aligning instruction with global mission and vision of the LEA.
Students	Middle School students participating in Student Athletic Leadership Team (SALT) and the Leadership (ASB) class were administered an LCAP survey regarding school climate, LCAP priorities and social-emotional well-being.

LCAP survey data continues to emphasize that teachers and parents identify that students being academically challenged as a high priority. Additionally, while parents see field trips as important to their child's education, they identify greater focus on academic rigor and classroom time as being a top priority. Parents and teachers continue to be concerned regarding student's ability to regulate their emotions and how

high anxiety levels impact student attendance and engagement. Parents would like to see expanded educational opportunities for foreign languages and instrumental music.

## Goal Analysis [2024-25]

TVCS engaged with PARSEC Education to provide individual and grade-level coaching on aligning instruction with grade-level standards including re-aligning scope and sequence for each grade level to ensure a focus on essential standards and learning at each grade level. Additionally, teachers received professional development from IXL trainers in order to more effectively utilize IXL to maximize student benefit.

The use of evidence-based, standards-driven instruction Professional Development with Parsec has proven to be effective. The overall increase does not actually reflect the true math growth of most students as a single grade-levels significant underperformance lowered the Average down for the entire LEA. Most grade levels made 8-10% points growth in Math with noted increased in 6th, 7th, & 8th grades. IXL scores do not appear to be correlated to assessment outcomes. The most growth is noted in students classified as socioeconomically disadvantaged. There is no correlation to grade levels scoring higher on CAASPP and level of IXL usage.

No additional changes will be made to the planned goal as there is still room for growth in Math achievement. However, data from after school Math intervention programs, targeted specifically at moving students from Level 2 to Level 3 CAASPP scores did not result in this identified goal. Therefore, TVCS has hired a Math TOSA to provide MTSS support to low-achieving students in grades 4th-8th through pull-out, push-in and a Middle School Math Support course. The Math TOSA will primarily provide interventions during the course of the school day.

Implementation began with each grade level revising their scope and sequence under the guidance of Parsec Education to reflect essential standards for instruction and intervention. Additionally, teaching staff regularly implemented data conference to examine their formal and informal assessment data to restructure teaching strategies to increase student mastery. Teachers met monthly with Parsec Education to conduct data conferences and identify strategies for addressing gaps in student learning.

CAASPP ELA scores continue rise indicating instruction is being targeted in areas of greatest need. Specifically, we are noting increased scores in students classified as socioeconomically disadvantaged and students with disabilities. Although ELL scores went down slightly, ELL represents only 11 students throughout the LEA.

An additional action item is being added in the area of Professional Development to continue to build educator skills data driven instruction and intervention. Parsec Education will additionally be supporting TVCS in ELA as well as Math.

TVCS has a 10.8% chronic absenteeism rate which impacts student achievement for those students who miss an excessive amount of school. Analysis of data indicates that these rates are particularly high amongst English Language Learners 23.1%.

## Goal Analysis [2024-25]

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

TVCS focused on rewarding students who were obtaining high attendance levels. For example, if an entire class had perfect attendance for the day, they were rewarded with pencils, stickers or gift certificates from local food establishments. Students achieving perfect attendance on a monthly basis were rewarded with small gift cards, prizes, and acknowledgement in front of their peers. A large end of year celebration for students achieving a Positive Attendance rate of 98% or better included hot air balloon rides on the football field for students achieving at this rate.

The expenditures for the ELL Parent group are lower than anticipated due to lower than estimated attendance at these parent meetings.

Initially, students who were attending at a rate below 95% were kept from extracurricular activities; however this action was found to negatively reinforce students whose parents were making the decision to not attend school.

No major changes are being made to this goal. Again, positive attendance is reinforced and poor attendance, for middle school students, is tied to participation in athletics, performing arts and field trips.

The results of the LCAP student survey indicated that 80% or more of students at least "somewhat agreed" with the following statements: "I am happy that I attend TVCS"; "My personal needs are being met at TVCS"; "I feel TVCS does a good job at community building activities"; and "My school is a safe place to learn". However, qualitative analysis of student responses indicated a desire for more community building activities for middle school students and a wider variety of clubs and sports that appeal to a broader group of students.

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

## LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.
