- Pg17- the fiscal information for this section is missing, making it hard to know if the LEA meets the total percentage requirement. Please fill in all fiscal information at the top of this section.
- Pg 18- Actions 1.3 and 1.4 are missing the metrics to monitor effectiveness.

- While your action tables are included, they are missing pertinent information. The boxes at the top of each section should include fiscal information such as the LCFF base grant, supplement and concentration dollars, and the percentage to increase or improve services.
- The instructions for the main LCAP template are missing.

Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Located in the beautiful French Valley area of Temecula, Temecula Valley Charter School is celebrating its 30th anniversary as a charter school. Founded in 1994, originally as a district charter known as Temecula Learning Center, TVCS is a thriving school focused with a family-centered approach to academic rigor, experiential learning and intense focus on science and the arts. Its Vision Statement states that "Temecula Valley Charter School will provide an innovative and enriching educational environment expecting all those involved in the learning community to grow and achieve academically, emotionally, socially, and artistically in order to promote personal excellence. Despite its small size, TVCS boasts an award winning performing arts department, a robust interscholastic sports program with at least 9 sports played annually, a recognized visual arts program highlighted during its annual community wide Art Show and various specialty clubs and activities. TVCS students also annually give back to their community through events such as "TVCS Has Heart" and our annual food drive entitled the "SouPer Bowl". Due to its centralized location in Winchester, it draws students from several surrounding cities including Hemet, San Jacinto, Romoland, Temecula, Murrieta, Menifee and Lake Elsinore. During the 2023-2024 school year, TVCS' enrollment averaged 530 students in grades TK-8th grade. The demographics of TVCS indicate that 51.9% of our students are male, 48.1% of our students are female. Data from the 2022-2023 school year indicate that our students identify as approximately 41% Hispanic, 7% Black or African American, 37% White, 8% Two or more races, 3% Asian and 4% Filipino. Unduplicated students are represented by Students with Disabilities (12.8%), Socioeconomically Disadvantaged (18%), Homeless (0.1%) and currently no Foster students.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

A review of Dashboard Data indicates that while CAASPP assessments indicate that TVCS is performing better than the local districts and counties, a significant portion of our students are not meeting state standards in the area of Mathematics. Additionally, although our students perform well in English Language Arts, the scores have flat-lined over the past couple of years. Our data indicates that we are continuing to make good progress in the academic achievement of subgroups such as students with disabilities, African-American students and students identifying as "more than two races". Chronic absenteeism continues to be a challenge for TVCS and our data indicates a 10% Chronic

Absenteeism rate. Finally, while our dashboard data reflects low suspension and non-existent expulsion rates, AERIES guidance logs indicate on-going challenges with students being respectful to each other and to staff. Additionally, anxiety remains high for many of our students and contributes to our chronic absenteeism rate.

LCAP survey data continues to emphasize that teachers and parents identify that students being academically challenged as a high priority. Additionally, while parents see field trips as important to their child's education, they identify greater focus on academic rigor and classroom time as being a top priority. Parents and teachers continue to be concerned regarding student's ability to regulate their emotions and how high anxiety levels impact student attendance and engagement. Parents would like to see expanded educational opportunities for foreign languages and instrumental music.

Dashboard data reviewed from the 2022-2023 data indicates that while TVCS continues to perform academically above both state and county performance levels our growth has stagnated over the past 2 years. Learning gaps continue to be present, particularly in the area of Math. Additionally, TVCS as a school of choice receives students from a variety of educational environments on a yearly basis and these students are often significantly behind in core competencies such as number sense of language mechanics. We are seeing evidence of effective Tier II interventions in the area of Reading for students identified as being at risk of dyslexia. Local indicators such as Fountas & Pinnell data indicate a high number of students reaching grade level reading skills as a result of targeted interventions in phonemic awareness, decoding and comprehension.

Alignment

Describe the efforts that the LEA will take to align use of federal funds with activities funded by state and local funds and, as applicable, across different federal grant programs.

Temecula Valley Charter School's LCAP is a comprehensive document that is developed with feedback from all Educational Partners. Results from LCAP surveys and local indicators were shared with partners and feedback was solicited to guide the development of the plan. Progress on LCAP goals is shared on an annual basis during a board meeting. All fund sources, base, supplemental, federal funds (including Title 1), as well as grants are accounted for in the LCAP. The goals that were developed in conjunction with the LCAP educational partners are specific to the needs of the students and include academic, social-emotional, and school climate goals that align to the LCAP. The Administrative Team, which consists of the Executive Director and Vice-Principal as well as other school leaders including the school psychologist, student services team members, parents and board members were updated on the LCAP progress at regularly scheduled board meetings. Parent input was sought through parent engagement events, LCAP Partner meetings with parent representatives and a LCAP parent survey. Students were surveyed through administration of a Student LCAP survey. TVCS is actively building partnerships within Winchester and surrounding communities and conversations with local community partners occur as a result of these relationships.

Parents are encouraged to create an Aeries Parent account to monitor student progress and read/respond to teacher emails updating student progress. Additionally, parents are notified of local assessment scores (STAR Testing) and are mailed reports of CAASPP scores. These reports explain how to read and interpret student test data. Guidance on how to read score reports is sent in both English and Spanish. Additionally, the student services team actively solicits parent feedback and concerns/input on the development of Individualized Education Plans (IEPs), 504s and Student Study Team meetings as TVCS seeks to address the individualized needs of each student. Teachers share benchmark assessment data with parents during parent meetings, through email, and regular communication using modalities such as Parent Square. TVCS has initiated an AVID program to help build and support students in being college and career ready as they enter their high school years. Parent communication emphasizes the importance of the adherence to state standards on the part of school staff as essential for the academic development of each student. As a small charter school we collaborate with various community agencies such as Riverside County libraries, museums, and higher-education institutions to provide resources and expertise that promote parent empowerment.

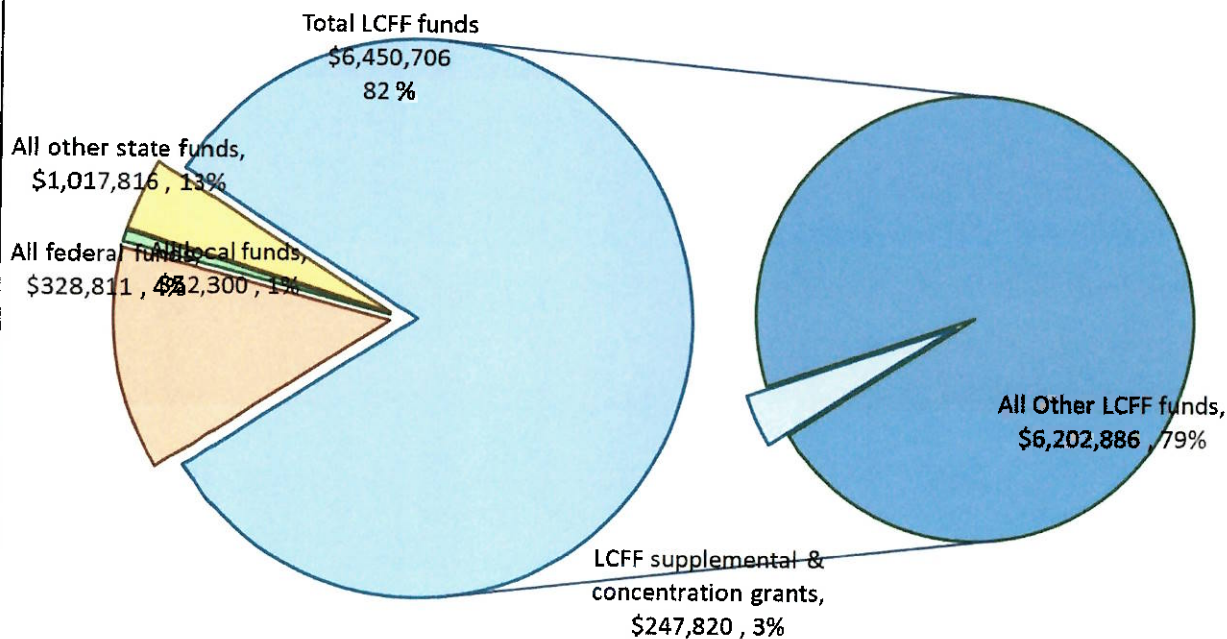

Projected Revenue by Fund Source

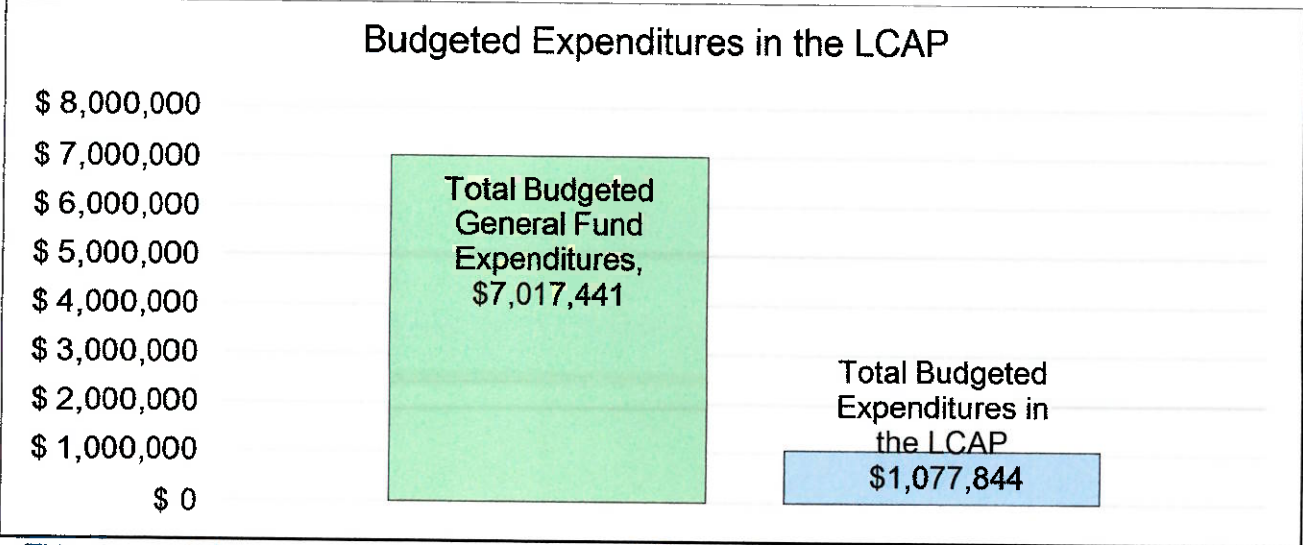

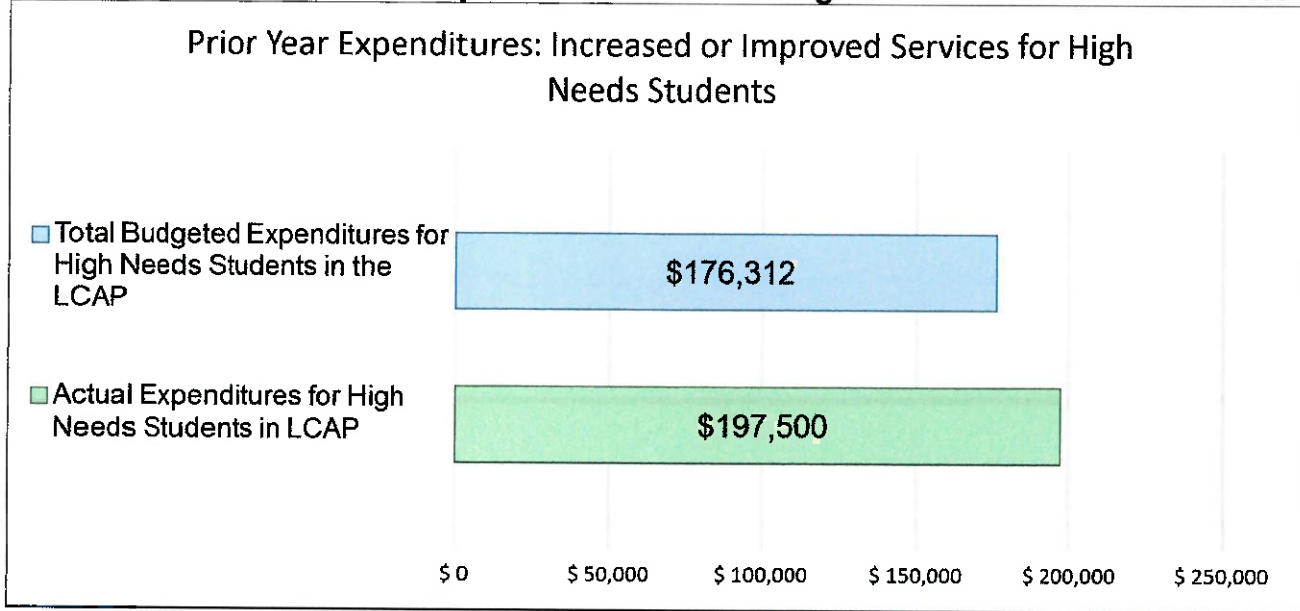

During this school year TVCS partnered with PARSEC Education to conduct deep dives on student academic achievement data. This data was utilized in grade level PLCs for structuring instructions and interventions. Additionally, interim assessment data from Fountas & Pinnell, IXL assessments and STAR assessments provided feedback to teachers for targeting instruction.

School Climate (LCFF Priority 6)

The initial design of the Local Control Funding Formula recognized the critical role that positive school conditions and climate play in advancing student performance and equity. This recognition is grounded in a research base demonstrating that a positive school climate directly impacts indicators of success such as increased teacher retention, lower dropout rates, decreased incidences of violence, and higher student achievement.

Approximately, 9.5% of parents completed the LCAP survey. Overall, parents report a healthy school climate with 97.9% of parents indicating that they Strongly Agree (69.4%), Agree (16.3%) or Somewhat Agree (12.2%) that their child attends TVCS. In terms of community building 51% of parents strongly agreed with the statement "I feel TVCS does a good job with community building activities, 22.4% Agreed and 22.4% Somewhat agreed. An overwhelming 81% of parents indicated that their child's school was a safe place to learn and another 9.5 % indicated that it was somewhat safe.

Student perceptions of school climate were also captured by surveying middle school students with a 20% response rate of all middle school students. Almost 80% of students who responded indicated that they either "Strongly Agreed" or "Agreed" that they were happy that they attended TVCS. When asked about whether their personal needs were being met, 46% indicated that "TVCS does an outstanding job", 25% indicated that "TVCS does an outstanding job" and 21% indicated that TVCS does an "okay" job. When given the prompt "my family feels welcome at TVCS", 62.5% strongly agreed, 17,% Agreed and 12.5% somewhat agreed with that statement.

Overall, student comments appeared divided on whether or not TVCS had enough opportunities for activities and social-emotional learning, with many students saying "we need more privileges for middle school students" and other students stating "we need more activities". In analyzing this data, TVCS will continue to build on its social-emotional engagement opportunities by offering a wider variety of activities in building off our model of robust athletics and performing arts programs. Additionally, TVCS will continue to focus on relationship building between students and school staff.

TVCS will continue to prioritize school climate and wellness in the LCAP with the addition of a Dean of Students to oversee campus team building activities, engage community members, and continue to build activities that appeal to a broad range of students. Additionally, all staff (including classified staff) will continue to receive training in social-emotional learning and building positive relationships with students utilizing the Mindset Behavioral Training certification. TVCS is adding additional clubs (eg. Chess) and competitive academic opportunities (eg. Pentathlon) to appeal to students who are not drawn to Performing Arts or Athletics.
